Resolution #51 of 2022

WHEREAS, the Town of Grafton Town Board desires to maximize savings for the taxpayers of the Town of Grafton while still maintaining efficient services for Town resident, so as to best achieve Town purposes, and

WHEREAS, the position of Confidential Secretary to the Town Supervisor no longer appears to be a necessary and vital Town Officer Position, and

WHEREAS, Section 29 (15) of the New York State Town Law states that "In towns of the second class, the town board may by resolution authorize the supervisor of the town to designate a bookkeeper or confidential secretary, or both", but does not require the creation or continuance of such positions, and

WHEREAS, the Town Board believes that the Town Bookkeeper provides the only necessary services required at this time,

NOW, THEREFORE BE IT RESOLVED, that on behalf of the Town of Grafton, the position of Confidential Secretary to the Supervisor shall be discontinued and eliminated at close of business on December 31st, 2022.
